Why does South Carolina need a Marriage Amendment Campaign?

- ✓ Same-sex couples are getting “married” in Massachusetts right now.
- ✓ States may recognize these Massachusetts “marriages,” because they don’t have laws or Constitutional Amendments to stop them.
- ✓ SC has a simple marriage *law*, but it is in danger of being voided by activist courts.
- ✓ *Constitutional Amendments*, on the other hand, more strongly reflect the views of the people, and are much more difficult for courts to ignore.
- ✓ Defeat of the SC Marriage Amendment could force recognition of Massachusetts marriages in South Carolina.

If we allow marriage to mean *anything* in South Carolina, it will mean *nothing*.

We must take action now to pass the SC Marriage Amendment on Nov. 7th.

Q Why should marriage in South Carolina be restricted to a man and a woman?
